TERMS AGREEMENT:

The undersigned ("Purchaser") agrees that all purchases made by Purchaser from Randall Industries/Detroit Radiator or any of its subsidiaries and affiliated entities ("Seller") are subject to the following terms and conditions.

1. All information on this application is true and correct. Randall Industries/Detroit Radiator is authorized to make such credit investigations as it sees fit, including contacting trade references and banks and obtaining credit reports. My company and I authorize all trade references, banks and credit reporting agencies to disclose to Randall Industries/Detroit Radiator any and all information concerning the financial and credit history of the applicant.
2. All amounts due Seller are payable in accordance with the payment terms granted by Seller's Credit Department from which the goods and services are delivered. If any amount due Seller is not paid in accordance with such payment terms, a delinquency charge shall be added to the sum due, which charge shall equal the amount obtained by multiplying the delinquent balance by the lesser of (a) one and one-half percent (1.5%) per month or (b) the maximum lawful rate permitted to be charged under the applicable state's law.
3. Purchaser shall pay Seller a returned check fee in the amount of \$35.00 for all checks returned unpaid by Purchaser's bank.
4. In the event the account is turned over to an attorney or other agency for collection, or suit is brought on same, or the same is collected through any judicial proceeding whatsoever, Purchaser shall pay all collection costs, reasonable attorneys' fees and court costs incurred by Seller.
5. Purchaser shall notify Seller by certified mail of any change of ownership of Purchaser.
